

ADDITIONAL PERMIT REQUIREMENTS

- 1) *AN ELECTRICAL PERMIT IS REQUIRED IF ANY ELECTRICITY IS TO BE USED TO POWER LIGHTING AND OR EQUIPMENT.*
- 2) *A MINIMUM OF A 2A10BC FIRE EXTINGUISHER IS REQUIRED FOR EACH TENT. EXTINGUISHERS SHALL BE A CONSPICUOUSLY LOCATION AND READILY ACCESSIBLE IN THE EVENT OF A FIRE.*
- 3) *EVERY TENT SHALL HAVE AT-LEAST TWO STANDARD EXITS LOCATED AT OPPOSITE ENDS OF THE TENT. THE MINIMUM EGRESS WIDTH IS 72 INCHES.*
- 4) *ILLUMINATED EXIT SIGNS ARE REQUIRED IN ALL TENTS WHERE MORE THAN 100 PERSONS CAN BE ACCOMMODATED.*
- 5) *NO SMOKING SIGNS ARE REQUIRED TO BE CONSPICUOUSLY POSTED IN ALL TENTS OPEN TO THE PUBLIC.*

THIS LIST IS NOT INTENDED TO LIST ALL OF THE CODE REQUIREMENTS FOR ERECTING A TENT. A COMPLETE LIST OF REQUIREMENTS IS AVAILABLE FROM THE OFFICE OF THE BUILDING INSPECTOR AND WILL BE GIVEN TO EACH PERSON REQUESTING A PERMIT.

PERMIT REQUIREMENTS

A permit is required to erect any tent that measures 100 square feet or greater in size.

EXEMPTIONS

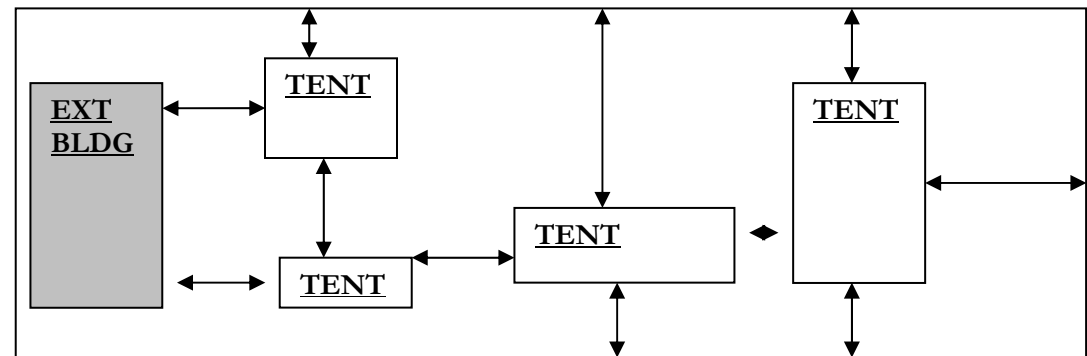
Any tent used for recreational use on a residential property and not to be erected for more than a 48 hour period in any two week period is exempt from obtaining a permit. However these tents are required to comply with all requirements of the City Of Racine.

SHOW DISTANCE TO PROPERTY LINES, BETWEEN TENTS, AND TO ALL BUILDINGS ON THE SITE.

To obtain a permit you will need to provide the building inspector with a plot plan drawn to scale showing the proposed location of the tent(s), the size of the tent(s), the distance measured from other buildings located on the site, and the distance from the lot lines must also be shown on the plot plan.

PERMIT FEE.

A **Permit Fee of \$30.00** is required for each tent to be erected. This fee is payable to the building inspector in the form of check or cash at the time the permit is requested. The office hours of the Building Department are Mon. – Fri 8:00am – 9:30 am and 1:00pm – 2:30pm . If you cannot schedule your visit during these hours please call for an appointment.
